7. DECLARATIONS OF INTEREST

Cllr Holland-Delamere declared a non-pecuniary interest in the Councillor Grant applications (a) and (b) Community Spaces Northampton and Emmanuel Group of Churches as he had endorsed them and they were to come from his councillor grant funding and (c) Emmanuel Group of Churches (second application) as he was a Trustee of the organisation. Cllr Holland-Delamere took no part in the deliberations of the applications (a) and (b).

Cllr Birch declared a non-pecuniary interest in application (d) to the Councillors Grant Scheme, little Fishes Pre-School since they were based in Lodge Farm Community Centre, and she was a Trustee of the organisation which managed the Community Centres.

8. GRANT APPLICATIONS TO THE COMMUNITY GENERAL FUND FOR THIS FINANCIAL YEAR

The members of the Sub-Committee considered each application and the supporting information included in the agenda. It was noted that the grant awards could be made in accordance with the General Power of Competence which the Council held. It was noted that the budget heading for Community Grants had £50,000 in the present financial year of which £7,325 had been allocated at the previous meeting leaving £42,675.

10. FURTHER INFORMATION ON DEFERRED APPLICATION FOR FAAWN

<u>Update on events – report of Administration Officer</u>

Purpose of report: To update the committee on the events taking place in Northampton.

Recommended: It is recommended that the committee note the report.

Background

At the time of writing, WNC were continuing to take the lead on events with some input from NTC officers. The budget is yet to be transferred from WNC, though the Heads of Terms for this have been agreed. We are awaiting WNC's legal team. The Leader and Town Clerk have sought clarity from WNC about the budgets and what is being spent on each event, in real time.

Northampton in Bloom

Progress on this project is reported through the Environmental Committee.

Bands in the Park – Abington Park – Sunday afternoons throughout the Summer The majority of the booked bands were able to perform however 2 bands had to cancel in September due to band members having to self-isolate.

Party in the Park – Abington Park

27th & 28th August (12:00 – 11.00pm)

WNC (NTC) events funding supported the stage, pa, lighting and waste collections /removal for the event. No additional NTC funding was provided.

This was the first year for this event and was a success with many visitors expressing positive comments through various social media outlets. No additional NTC funding was allocated to this event.

NMF21

On Sunday 5th September a very successful event took place offering 6 stages across the town centre, the date for NMF22 has been confirmed as **19th June 2022**.

£10,000 allocated to this event out of the WNC (NTC) events budget.

NTC were pleased to be able to support this event with a grant of £5,000 from the Community General Fund, the monies funded additional pop up stages and promotional costs.

Pride LGBTQ

12th September, Market Square (11.00am - 4.00pm)

Parade, performers and entertainment. The WNC (NTC) event funding provides support for this event. No additional NTC funding has been allocated on this occasion.

Beer Festival

Beckets Park - 9th - 11th September (11.00am – 11.00pm)

The annual beer festival at Beckets Park receives funding from the WNC (NTC) events budget which is being transferred to NTC. The funding covers the provision of the stage, pa, lighting and the waste collection and removal. No addition NTC funding has been given to this event.

Diwali Light Celebration

Saturday 30th October, Market Square (3.00pm – 8.00pm)

21st anniversary of this event - Stage, invited guests

Schools involvement, Lantern making Workshops, Light Parade (circular route around the town centre) at 6pm – a rolling road closure is in place

Event led by IHWO Northampton with partners WNC and NTC

WNC (NTC) events budget support the event with regard to the stage, pa, lighting, traffic management and security / stewards.

Fireworks Event -

Saturday 6th November, Northampton Racecourse

4:30pm – Entertainment

6.00pm - Fireworks

Fireworks, stage, stage crew, security, sound system, children's entertainment etc. booked

NTC additional funding of £7500 was added to this existing WNC event funding (agreed at NTC Executive Meeting on 12th April).

The additional Firework enhancement funding included extending the firework display content (bigger bangs) to provide a more spectacular finale - £5000

Plus 2 x additional LED Screens and sound - cost £2440

Total additional spend = £7440

Remembrance Parade – Sunday 14th November

Parade and All Saints Church Service.

The parade of armed forces (cadets, serving and retired) will marshal-up on the Market Square for a 9.30am parade down to All Saints.

The Church Service will begin at 10.00am in All Saints Church with the ceremony finishing in the memorial garden for the two minutes' silence at 11.00am followed by the wreath laying.

The parade will then march around All Saints, along St Giles Square where the formal salute will take place outside the Guildhall with the Lord Lieutenant and the Mayor, after which the parade will move along St Giles Street, into Fish Street and finish in Abington Street.

WNC (NTC) event funding is provided to cover various costs including all traffic management requirements, pa systems, marketing etc.

<u>Proposed enhancement to Christmas Activities – report of Administration Officer</u>

Purpose of report: To update the committee on the current position with regards to the Christmas plans in Northampton

Recommended: It is recommended that in order to support the existing Northampton 2021 Christmas plans and to work with partners (WNC, Northampton BID, theatres and Grosvenor Centre) to encourage visitors to the town centre that NTC provide additional street entertainment throughout the Saturdays in December and introduce a Christmas Augmented Reality Trail (see details below).

Background

The shadow Council agreed a budget of £15,000 to enhance Christmas events in 2021. The original minute proposed free standing illuminated attractions, a moving light show on the Guildhall (subject to consent of WNC), and additional street entertainers in the lead up to Christmas. These options have been looked at further in conjunction with WNC and the Northampton BiD, the details of which are covered in the Enhancement section.

Christmas 2021 - Key Dates and activities

Saturday 20th November-Christmas Lights Switch On

Times: 11 - 5:30pm

Stage and activities on Market Square Local Pantomime Stars – R&D and Deco

 4×40 -ft spruce trees Market Square, St Giles Square, All Saints Plaza, Abington Square and 2×14 -ft spruce trees outside the Guildhall (all trees to be installed Tuesday 9th November).

200 small Christmas trees in the business hanging basket brackets at various business premises on the Wellingborough Road and around the town centre.

The 2021 Christmas Lights will be the same as previous years which includes decorations in the Town Centre, Wellingborough Road and St Leonards Road.

As in previous years the lights on the Market square and Guildhall will be installed prior to 30th October to enable switch on of these lights as part of Diwali 2021 celebrations. These will be switched off after Diwali and back on with the rest of the Christmas lights on Saturday 20th November.

Christmas parade provided by Festive Road (traditional theme Stage entertainment on the Market Square

Northampton Town Centre BID

- The annual Golden Ticket competition will be launched at the town Fireworks event, there will be 14 post boxes around the town from Sunday 7th Nov Friday 10th December. 4 x £500 prizes, Prize draw to be held on Sat 11th December
- Christmas Shop Window competition
- Shop Local showcase online
- Looking to provide a Santa's Grotto on Market Sq. on Lights Switch On day plus 2 x roaming characters
- The BID manager is speaking to WNC regarding the possibility of free parking TBC
- Considering a late night shopping event on 16th December depending on the outcome of consultation with local businesses, BID would provide a Snow Globe photo opportunity on the Market Square.

Enhancements to activities - NTC - additional budget £15,000

- Illuminated display Christmas Sleigh (St Albans) or illuminated Arch (Leighton Buzzard)
 These could be in place for a day, week or the whole Christmas period and provide photo
 opportunities. Please note overnight security costs could be an issue if displays are
 positioned outdoors, the illuminated display would need to be near a power source and
 installed in a way that they cannot be climbed on etc.
- 2. **Illuminated buildings** considerations include timings, which buildings and what is our audience? Some buildings i.e. the Guildhall and All Saints are already lit up for Christmas. The lighting is not visible during the daytime when we need to encourage families to come in and support local retailers. Will people make a trip into town just to see a building that has been lit up, does this appeal to families?
- 3. **Provision of additional 'family street entertainment' around the town** centre on the weekends of Christmas activity in December. As part of the existing Christmas activities roving street entertainers could "pop up" in places other than the main shopping streets and encourage people to explore the whole of the town. This offers a broad brush approach and introduces people to new areas and shops they may not have visited before. Cost approx. £10,000 to be spread across the Christmas family activity days throughout December.

4. Introduce a Christmas themed Augmented Reality Family Trail

The Augmented Reality Trail is a new digital activity that leads families on a journey around the town in search of different locations, markers are identified where animated characters' pop up. Visitors are prompted to open the camera on their device and scan the area to locate and be photographed with one of 10 friendly augmented reality themed characters lurking in the streets of the town centre. Interesting fun facts or part of a story will also be revealed. Self-led trails such as this one are an engaging, and fun experience that encourage families to come into the town centre.

Previous trails held in Northampton include A Walk in the Park, the Northampton Museum & Art Gallery Shoe Gallery and the Dino Trail have been well received. All trails have been promoted through the **Explore Northampton App** which has seen over 1,500 downloads in total since the release in Dec 2020, (Installs on Android: 608 and Installs on iOS: 954).

NBC, Northampton Museum and the BID have worked with local business, AR Media to provide their AR Trails. AR media have quoted a cost of approx. £5,000 to create a story based augmented trail which could be promoted alongside the other Northampton trails via the Explore Northampton App.

Request for the Council to add facilitate two Eid events in 2022

Purpose of report: To advise the committee of a request from councillors to support two Eid events in 2022

Recommended: It is recommended that the Committee support in principle the idea of events to mark Eid and that this be taken forward when considering budgeting in the coming months.

Background

The Castle Ward councillors have requested that the council consider financially supporting two events to mark Eid.

They have summarised it as follows:

Request for the Town Council to put on two Eid events annually (season and weather permitting).

The purpose: -

The Muslim community is very diverse and this is an opportunity to bring everyone together. In these difficult times, especially for our Afghan brothers and sisters, it is ever more important to attend to the well-being of all the community.

This will help the families feel valued and respected.

The events will cater for families and children.

The events will include:-

The Committee will be looking at their budget in the coming months and can build this into that process. Costings and an event plan would need to be established and also what level of support the Council can provide beyond financial. As explained previously the Council are still working with WNC on the events budget and how it works. This could be an event that the Council could engage Stage Right Productions (current events support contractors for WNC) in assisting with.

Knife Angel Background

It is understood that the Knife Angel will be visiting Northampton in May 2022.

The sculpture, made from over 100,000 seized blades, was specifically created to highlight the negative effects of violent behaviour whilst solidifying our critical need for social change. Not only does the Angel act as a catalyst for turning the tide on violent and aggressive behaviour, but it is also acts as a beautiful memorial designed to celebrate those lives who have been lost through these violent and thoughtless actions.
